
- (2) Ancelmo Ornelas, Frio County Road and Bridge Administrator, requests:
  - 2.1 Consider/take action on approving a waterline permit to Formentera Operations, LLC. The facility will consist of a 4" temporary waterline which will be installed above ground on CR 3000 (Keystone Rd). Total permit fee \$150.00.
  - 2.2 If the permit is approved, consider/take action on approving a resolution authoring Hon. Rochelle Camacho to sign the permit to Formentera Operations, LLC.
- (3) Hon. Rochelle Camacho, Frio County Judge, requests:
  - 3.1 Consider/take action to approve an interlocal agreement between Frio County and the Alamo Area Council of Governments (AACOG) for AACOG to provide grant writing and grant administration services to the County for the Southwestern Border Regional Commission (SBRC) Economic and Infrastructure Development (EID) Grant Program beginning April 2, 2025 and ending December 31, 2029.


